The Brazilian Institute of Development and Sustainability (IABS) has received financing from the World Bank toward the cost of the Transition to Electromobility in Brazilian Cities, and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include (i) presenting the context, opportunities and barriers related to transition to electromobility; (ii) stablishing the political, technological, social and industrial paths to transition to electromobility in Brazilian cities; (iii) systematizing the transition steps for electromobility, considering the different paths for implementation, as well as the different conditions and needs from each location; and (iv) applying pilot project in tow Brazilian cities. The Services will enable the improvement of urban mobility managers and technicians in the public sphere, private and civil society for planning, implementing and monitoring policies, actions and projects that assist in the transition to electromobility in Brazilian cities. To accomplish this services are expected to start in early 2021 and will have a period of eight months to be performed.

The IABS now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are: the consultancy company must have experience of at least 4 years in the development and application of urban mobility studies, considering national and internationally recognized experiences in electromobility, as well as structuring or evaluating sustainable projects, including criteria, technicians, environmental, social and governance issues in Brazil. Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" July 2016 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-

consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Quality and Cost-Based Selection method set out in the Procurement Regulations.
